4. Purposes of Processing and Legal Bases

We process personal data for the purposes set out below, in accordance with Article 6 GDPR.

5. Children's Data

6. Data Sharing

We do not sell personal data. We may share personal data with:

- Service providers acting on our instructions (e.g. IT, hosting, communications)
- Regulatory or statutory bodies, including Tusla, where required by law
- Insurers or professional advisers where necessary

All third parties are required to comply with data protection law.

7. International Transfers

Personal data is primarily processed within the European Economic Area. Where data is transferred outside the EEA, appropriate safeguards are applied, including Standard Contractual Clauses or adequacy decisions.

8. Data Retention

We retain personal data only for as long as necessary for the purposes for which it was collected and in line with legal and regulatory requirements. Retention periods vary depending on the nature of the data and applicable obligations.

9. Your Data Protection Rights

You have the right to:

- Access your personal data
- Rectify inaccurate data
- Request erasure, restriction, or objection to processing
- Withdraw consent at any time where processing is based on consent
- Automated decision making – right for human oversight
- Lodge a complaint with the Data Protection Commission

Parents or guardians may exercise rights on behalf of children, subject to safeguarding considerations.
